# Subject: Notice for Inviting Bids for Renovation of Swimming pool at India House.

## 1. Introduction

## 1.1 Purpose

Bids/quotations are invited from reputed companies for the complete renovation of the swimming pool in India House, located at Avenida da Torre de Belem Nº10/10A, Lisbon, Postal Code: 1400-031. The renovation seeks to improve the pool's safety, aesthetics, and operational efficiency while ensuring compliance with all applicable regulations.

## 1.2 Background

The current swimming pool is old but it was not operational since last 6 months. It is suspected that there are some leakages inside the walls/tiles due to which the water level has been going down and the filters were not able to filter/purify the water. Due to this reason, the water in the pool was removed and the swimming pool is left empty.

## 2. Scope of Work

The project encompasses the following key components:

- Structural Repairs:
  - Assess and repair the pool shell for any cracks or damages.
  - Reinforce structural integrity as necessary.
- Pool Liner Replacement:
  - Remove existing liner and install a new, durable liner.
  - Ensure proper sealing to prevent leaks.
- Filtration and Circulation System Upgrade:
  - Replace existing filtration systems with energy-efficient models.
  - Upgrade pumps, skimmers, and return inlets for optimal water circulation.
- Decking and Surrounding Area:
  - Remove old decking and replace with slip-resistant materials.
  - Enhance the landscape around the pool area.
- Lighting Installation:
  - Install energy-efficient LED lighting both in and around the pool.
  - Ensure all lighting complies with safety standards.

# • Compliance and Safety:

- Ensure all work meets local health and safety regulations.
- Install necessary safety features, including signage and barriers.

## **3.2 Key Milestones**

- Mobilization of equipment and personnel.
- Completion of structural repairs, installation of new filtration systems, Decking replacement etc.
- Final inspection and handover.

# 4. Eligibility Criteria

To be considered for this tender, the bidders must meet the following criteria:

- At least 5 years of experience in swimming pool renovations.
- Relevant licenses and certifications in construction and pool management.
- Evidence of financial stability (e.g., bank statements, credit rating).
- Minimum of 3 positive references from previous clients.

# **5. Submission Requirements**

Interested agencies are required to submit their bids in two separate sealed envelopes in the following manner:

i) <u>The First envelope (in the form of Annexure-I)</u> should be marked as "Technical Bid", the bidders are required to submit the following documentation:

- **Company Profile:** Overview of the company, including size, structure, and key personnel.
- **Project Proposal:** Detailed description of the approach, methodologies, and timelines.
- **Subcontractor Information:** List of any subcontractors, including their qualifications and roles.
- References: Contact information for at least 3 past projects similar in scope.

ii) The <u>Second envelope (in the form of Annexure-II)</u> should be marked as "Financial Bid" and should contain the following:

- **Cost:** Itemized breakdown of all costs associated with the renovation.
- All the invoices should be in the name of the Embassy of India, Lisbon (NIF: 900232013) and IVA should be explicitly mentioned on all the applicable invoices.

The above two sealed covers can be further submitted in a third/big and single sealed envelope with title: "Renovation of Swimming pool at India House." The bids should be submitted either in English or in English & Portuguese. Both the envelopes could be submitted in person or can be mailed to: Head of Chancery, Embassy of India, Rua Pêro da Covilhã Nº16, Lisbon 1400297 latest by 5 pm on 14 April 2025. Late submissions will not be considered.

The tender document may be downloaded also from Central Procurement Portal <u>https://eprocure.gov.in</u>. Please note that any corrigendum/addendum in the above tender documents, if required, will be hosted in the website of the Embassy of India, Lisbon.

# <u>6. Evaluation Criteria</u>

The evaluation of the bids involves two stages. First the Technical bid of all the bidders will be evaluated on the basis of the following criteria:

- **Compliance with Specifications:** Adherence to project requirements and scope.
- **Experience and Qualifications:** Demonstrated expertise in similar projects.
- Quality of Materials and Techniques: Proposed materials and methods for renovation.
- **Project Timeline:** Realism and feasibility of the proposed schedule.

Only those financial bids whose technical bids are qualified as per the criteria set by the Embassy, in the first stage, will be opened.

• **Cost:** The financial bids with the lowest quote value will be chosen for the renovation work of the swimming pool.

## 7. Terms and Conditions

## 7.1 Payment Schedule

• Complete payment will be made only after the successful completion of the renovation work. However, a small portion of the payment can be made in advance for procurement of raw materials needed.

### 7.2 Warranty

• A warranty period of at least 3 years, for workmanship and materials is required. Also, one dedicated contact person should be assigned for at least 3 months, to resolve any issues that arise after the completion of the work.

### 7.3 Health and Safety Compliance

• The contractor must adhere to all health and safety regulations and ensure that all personnel are trained and equipped to work safely.

#### **GENERAL INSTRUCTIONS**

1. The company/bidder must have a minimum of 03 years experience of handling similar kind of work in reputed organizations.

2. The persons deployed by the company should have requisite experience and skills for carrying out the assigned maintenance task using appropriate materials and tools/equipment. The contractor must employ adult and skilled labour only.

3. The company should have sufficient employees on its rolls specifically trained for this activity.

4. The company should clearly give the technical and quality aspects of the materials to be used for the renovation of the pool.

5. The company should also provide the details of warranty/guarantee of the pool/materials to be used for the pool, as applicable.

6. Rates quoted shall be firm and fixed. No additional charges apart from the charges mentioned in bid, shall be payable.

7. For finalization of work, the tender whose rates are the lowest in comparison to other bidders for the equal or better quality of materials, will be considered as the lowest bidder.

8. The Mission reserves the right to cancel this work/tender if no satisfactory bids are received from any of the bidders.

09. Physical visit to the Embassy building is advisable to have a general idea about the extent of works required.
